ARTICLE 1. NAME

- 1.1 The Alberta Division of Biathlon Canada Association, hereinafter called Biathlon Alberta, will be known as Biathlon Alberta and will use the name Biathlon Alberta except where use of the full registered name is required.

ARTICLE II. AFFILIATIONS

- 2.1 Biathlon Alberta is affiliated with the Canadian Ski Association - Alberta Division (CSA-AD), as the organization responsible for the Biathlon Discipline established in accordance with the BY-LAWS of CSA-AD.
- 2.2 Biathlon Alberta is the operating organization for the Alberta Division of Biathlon Canada.

ARTICLE III. MEMBERSHIP

- 3.1 Membership in Biathlon Alberta shall be in accordance with the By-Laws and policies of the CSA-AD, and of Biathlon Canada.
- 3.2 Membership in Biathlon Alberta will be on an individual basis with two primary categories of membership, defined as follows:

Full members: pay full fees, have full voting rights, and are entitled to all services offered by Biathlon Alberta.

Associate members: pay reduced fees, have no voting rights and are not entitled to all services offered by Biathlon Alberta. Cadets are included in this category.

- 3.3 All members of Biathlon Alberta will be registered by Biathlon Alberta as members of Biathlon Canada in the appropriate category, and will enjoy all the benefits provided by Biathlon Canada including insurance, newsletter etc., appropriate to their membership category.
- 3.4 All persons who wish to participate in Biathlon Alberta programs or activities must be members of Biathlon Alberta.

- 3.5 Membership fees in Biathlon Alberta shall be determined from time to time by full members at a general meeting. Biathlon Alberta will pay membership levies to Biathlon Canada and to CSA-AD as set by those organizations.
- 3.6 Any member wishing to withdraw from membership may do so by giving notice in writing to the Secretary. If any member is in arrears for fees or assessments for any year, such member shall be automatically suspended at the expiration of six months from the end of such year and shall thereafter not be entitled to any membership privileges or powers until reinstated. Any member may be expelled by a "special resolution" made in accordance with The Societies Act for any cause which Biathlon Alberta may deem reasonable.

ARTICLE IV. BOARD OF DIRECTORS

- 4.1 A Board of Directors ("Board") shall, subject to the by-laws or direction given to it by majority vote at any general meeting properly called and constituted, have full control and management of the affairs of Biathlon Alberta.
- 4.2 Directors must be full members in good standing
- 4.3 The Board shall consist of the following Directors:
- President
 - Immediate Past President
 - Vice-President, Technical
 - Vice-President, Administration
 - Secretary
 - Treasurer
 - Chairmen of all Standing Committees
 - Athlete Representative
- 4.4 Meetings of the Board shall be held as often as may be required, but at least once every six months, and shall be called by the President. A special meeting may be called on the instruction of any two members of the Board, provided they request the President in writing to call such meeting, and state the business to be brought before the meeting.

Meetings of the Board shall be called by giving ten days notice in writing to each Director, or by giving three days notice by telephone. Any five Directors shall constitute a quorum. Meetings may be held without notice if a quorum is present, provided that any business transactions at such meeting shall be ratified at the next regularly called meeting of the Board, otherwise they shall be null and void.

- 4.5 Directors shall serve for one year terms, and shall be elected by simple majority in a secret ballot by full members at the Annual General Meeting. Candidates (except Athlete Representative) shall be proposed by a Nominating Committee appointed by the Board prior to the Annual General Meeting, or may be nominated from the floor at the meeting. The Athlete Representative shall be nominated by athletes. Directors may serve for an unlimited number of consecutive terms.
- 4.6 Directors shall serve without remuneration, except, by resolution of the Board, compensation may be made for attendance at meetings of the Board.
- 4.7 Directors may resign from the Board by submitting a written resignation to the Secretary.
- 4.8 Directors may be removed from office by a "Special Resolution" made in accordance with The Societies Act.

ARTICLE V. EXECUTIVE COMMITTEE

- 5.1 Operations of Biathlon Alberta shall be administered by an Executive Committee of Officers which consists of the following members of the Board:

President
Vice-President, Administration
Vice-President, Technical
Secretary
Treasurer
Athlete Representative

- 5.2 The duties and responsibilities of the Officers are as follows:

President - is responsible for general supervision of the administration, management, and control of Biathlon Alberta, the calling of all General, Special, Board, and Executive Committee meetings, and shall chair all such meetings. He serves as Chairman of the Board and of the Executive Committee and is an ex-officio member of all committees.

The President is the Biathlon Discipline representative on the Board of the CSA-AD, and the Alberta Division Representative on the Board of Biathlon Canada.

Vice-President, Administration - is the first Vice-President and shall assume the duties of president whenever the president is absent. He is responsible for the administrative functions of Biathlon Alberta, including supervision of professional and other staff.

Vice-President, Technical - is the second Vice-President and shall assume the duties of president whenever the president and Vice-President, Administration are both absent. He is responsible for the technical functions of Biathlon Alberta.

Secretary - shall attend and keep accurate minutes of all meetings of the Executive Committee, the Board and the members of Biathlon Alberta. He shall have charge of all correspondence, and shall give all notices required to be given. He is responsible for the corporate seal and of all records and documents belonging to Biathlon Alberta.

Treasurer - is responsible for the financial planning and for the receipt, banking and disbursement of all monies. He shall ensure that accurate records are kept of all financial transactions and shall present budgets and full detailed accounts to the Board whenever requested. He shall prepare for submission to the Annual General Meeting a statement, duly audited as hereinafter set forth, of the financial position of Biathlon Alberta.

- 5.3 Meetings of the Executive Committee may be called by the President or at the request of two or more members of the Executive Committee. The Executive Committee shall meet at least two times per year.

ARTICLE VI. GENERAL MEETINGS

- 6.1 Biathlon Alberta shall hold an Annual General Meeting on or before June 30 in each year. Notice of this meeting, setting out the time and place shall be delivered to all members at least 3 months prior to the meeting. The agenda for this meeting shall be delivered to all full members at least 30 days prior to the meeting.
- 6.2 The Board of Directors and the Executive Committee shall be elected by the members at the Annual General Meeting, and shall serve until their successors are elected and installed. Any vacancy occurring during the year shall be filled at the next Annual Meeting. Any full member in good standing, except paid staff shall be eligible to serve in any office of Biathlon Alberta.
- 6.3 Special General Meetings of Biathlon Alberta may be called by the President on his own initiative, and shall be called by the President upon receipt by him of a petition signed by one third of the full members in good standing, setting forth the reasons for calling such a meeting. Notice of all Special General meetings, including an Agenda must be delivered to full members at least 10 days prior to the meeting.

- 6.4 Five percent (5%) of the the members in good standing shall constitute a quorum at any General Meeting of the members of Biathlon Alberta.
- 6.5 Each full member shall have one vote at General Meetings of the members.
- 6.6 Notices of General Meetings may be published in the "Biathlon Alberta Bulletin", or set out in a letter to each member, and such Bulletins or letters must be delivered by hand or by mail to members in accordance with the deadlines set out in paragraphs 6.1 or 6.3

ARTICLE VII. MANAGEMENT AND OPERATIONS

- 7.1 The Head Office shall be in Calgary, or at such other location in Alberta as determined by the Board.
- 7.2 The Board may exercise all such powers of Biathlon Alberta as are not, by The Societies Act or by these by-laws, required to be exercised by the members at general meetings, including but not limited to the following:
- a) carry on the business of Biathlon Alberta in accordance with the direction of members at General Meetings, including expenditure of Biathlon Alberta funds for goods, services and salaries, which, in the opinion of the Board are required,
 - b) make, vary, or repeal regulations to carry out the Objects of Biathlon Alberta,
 - c) direct the Executive Committee to exercise such powers of the Board as are delegated to it from time to time,
 - d) establish offices, engage employees, and appoint agents as it deems necessary from time to time to carry out the operations of Biathlon Alberta, under the direction of the Executive Committee.
 - e) acquire, own and maintain and dispose of property in Alberta, including land, buildings and equipment, which, in the opinion of the Board is required for use by members of Biathlon Alberta, except that aquisition or disposition of major assets requires a "Special Resolution" made in accordance with The Societies Act.

- 7.3 The Board shall establish and maintain a system of financial controls, which shall include annual budgets, regular reviews of performance relative to the approved budget, and clearly defined delegations of financial authorities. The financial controls shall be in accordance with CSA-AD requirements.
- 7.4 The fiscal year of Biathlon Alberta shall be from May 1 of a calendar year to April 30 in the next calendar year.
- 7.5 The Board shall designate, by resolution, the officers or other persons, authorized to transact the banking business and to receive and disburse funds on behalf of Biathlon Alberta. All banking business shall be carried out at a bank or trust company approved by the Board. The resolution shall clearly set out the powers which are delegated to such persons.
- 7.6 Contracts and other documents requiring execution by Biathlon Alberta shall be signed by the Treasurer and the President, or in the absence of the President by a Vice-President or a Director appointed by the Board, and any such contracts or documents shall be binding upon Biathlon Alberta. Where required, such contracts or documents may be signed under the seal of Biathlon Alberta, and by the President of CSA-AD.
- 7.7 The Board may establish Standing Committees, Competition Committees, or other special committees as it deems necessary to carry out the programs of Biathlon Alberta.

ARTICLE VIII - AUDITING

- 8.1 The books, accounts and financial records of Biathlon Alberta shall be audited at least once each year by a duly qualified accountant approved by the members, and an audited financial statement for the preceding fiscal year shall be presented to the members at every Annual General Meeting, or as soon thereafter as possible.
- 8.2 The members at each Annual General Meeting shall appoint one or more auditors to hold office until the close of the next Annual General Meeting, and if an appointment is not so made, the auditor in office continues until a successor is appointed. The Directors may fill any casual vacancy in the office of auditor.
- 8.3 The remuneration of an auditor appointed by the members shall be fixed by the members, or by the Board if so authorized by the Members. The remuneration of an auditor appointed by the Board shall be fixed by the Board.

- 8.4 The members, by a resolution passed by at least two-thirds of the votes cast at a General Meeting of which notice to pass such a resolution was given, may remove any auditor before the expiry of his term of office, and shall by a majority of votes at that meeting appoint another auditor in his stead for the remainder of his term.
- 8.5 The books and records of Biathlon Alberta may be inspected by any full member upon giving reasonable notice and arranging a time satisfactory to the officer or officers having charge of same. Each Director shall at all times have access to such books and records.

ARTICLE IX. BORROWING POWERS

- 9.1 General Borrowing Authority - subject to limitations set out in these by-laws, the CSA-AD By-Laws or The Societies Act, the Board may:
- a) borrow money upon the credit of Biathlon Alberta,
 - b) limit or increase the amount to be borrowed,
 - c) issue, reissue, sell or pledge bonds, debentures, notes or other evidence of indebtedness or guarantee of Biathlon Alberta, whether secured or unsecured, but this power shall be exercised only under the authority of the members by a "Special Resolution" made in accordance with The Societies Act,
 - d) mortgage, hypothecate, charge, pledge, or otherwise create, issue, execute, and deliver a security interest in all or any currently owned or subsequently acquired real or personal, moveable or immoveable property of Biathlon Alberta, including book debts, rights, powers, franchises, and undertaking to secure any such bonds, debentures, notes, or other evidences of indebtedness or guarantee or any other present or future indebtedness of Biathlon Alberta.
- 9.2 Specific Borrowing Authority - from time to time the Board may authorize an, Director, Officer, or employee of Biathlon Alberta to make arrangements with reference to the money so borrowed or to be borrowed and as to the terms and conditions of the loan thereof, and as to the security to be given therefor, with power to vary or modify such arrangements, terms and conditions and to give such additional security as the Board may authorize, and generally to manage, transact and settle the borrowing of money by Biathlon Alberta.





